# THE 91<sup>ST</sup> ANNUAL GENERAL MEETING OF KOPERASI JAFFNESE BERHAD

## 26<sup>TH</sup> JUNE 2022

The Annual General Meeting of Delegates (AGMD) was held on Sunday, 26th June 2022 at Kalamandapam, Brickfields, Kuala Lumpur. A total of 83 delegates out of the 87 eligible delegates attended.

In the elections for Board members for the period 2022 – 2025, there were 5 candidates. Those elected to the Board were Mr. S Sivashankar, Mr. K. Sivagnanasingham and Mr. A. Paramsothy. Mr. C. Mahavishnu and Dr. Christopher V.A. Nicholas were the others who stood for elections.

Subsequently, in the elections for the post of Chairman, Mr. P. Satguna Rajah was re-elected, and for the post of Vice Chairman, Dr. E. Sivananthan BCK was re-elected.

The delegates approved the following:

(1) 3 amendments to KJB Rules & Regulations and (2) 4 resolutions on investments and borrowings.

The details are:

1. Amendments to three (3) KJB Rules & Regulations:

1.1 To delete KJB R&R No. 1 (viii) on Monthly Subscription: When the subscription credit of a member exceeds RM20,000, the excess sum shall be transferred to the Special Deposit (Member) account.

1.2 To Amend KJB R&R No. 3 (vii) on Special Deposit - When a member is in arrears of subscription and / or any other dues for 3 or more months, the Koperai shall utilise the deposit in the Special Deposit (Member) account to offset the outstanding arrears and then notify the member that such an adjustment has been made. A member in arrears of subscription and / or any other dues for less than 3 months can make a formal written request to utilise the deposit in the Special Deposit (Member) account to offset the outstanding arrears.

1.3 To Amend KJB R&R No. 5 (i),(vi),(xi), (xii) and (xv) on loans and it's repayments. KJB is introducing 2 new loans: Personal Loan and Loyalty Loan.

## KJB TAIPING KAWASAN MEETING, 17<sup>TH</sup> APRIL 2022



# JCS EDUCATION AWARDS 2022

The ceremony was attended by about 150 students, parents, JCS Chairman Mr. P. Satguna Rajah, Board Members, District Chairmen and Secretaries, Committee members and Internal Auditors.

The Chairman in his speech pointed out that every year since the 1970s, JCS has been giving out this education awards to members children who excel in education, starting from UPSR, PT3, SPM, STPM including those who are continuing their education at first degree level. This event is also to recognize the excellence among our younger generation.

Since the Government has abolished UPSR and PT3, KJB is giving out a fixed amount of RM60 to each Child Depositor reaching the age of 12 years. This amount will be credited to their Special Deposit (Child) account. For Child depositors reaching the age of 15 years (PT3), RM100 is given out.

In this year's award presentation ceremony, 50 students who performed well in the SPM and STPM and equivalent like Malaysian Matriculation and IGCSE exams were recognised. JCS congratulates them all for the excellent academic performance.

The Chairman also thanked Mr. S. Makeswaran PPN, the Past Chairman of JCS and the Chairman of JCS PJ District for initiating the Makeswaran-Poovanes Education Fund to give an award to the top student for SPM or equivalent exam from JCS PJ District which was given out on the same date to Divani a/p Thisinayagam.

# AATHI ATTHI VARATHAR VAIBHAVAM 2019

In 2019, just after Chitthirai Puthandu something was brewing up to be the talk of the world and that was the above mentioned festival which took place in the holy land of Kanchipuram at the Varatharaja Perumal Temple.

It became a huge phenomenon because it was a once in 40 years event to take place & the reach was global all thanks to the social media (Internet, Facebook, Whatsapp, TikTok) which made hundreds of thousands of devotees attend it on a daily basis throughout the 48 days of it being celebrated which totalled to more than 1 crore (10 million) of devotees witnessed Aathi Atthi Varathar once it ended.

### **KANCHIPURAM**

Kanchipuram is one the Saptha Puri (7 holy pilgrimage cities / centres in India) for Hindus that one must visit in their lifetime (the rest being Haridwar, Mathura, Ayodhya, Varanasi, Ujjain & Dwarka) as it blesses the pilgrims with moksha (liberation from the cycle of birth & death).

Kanchipuram city is considered second to Varanasi city in fame and learning. This city in South India is called as Mummurti Vasam (Abode of Trio) as it has 108 Shaiva temples, 18 Vaishnava temples & the ever famous Kamakshi Temple (one of the 51 Shakthi Peethams). If I had to write about Kamakshi of Kanchi, that would be another story by itself.

Just a little to know what is the meaning of Kanchipuram means; Ka = Brahma, Anchi = Puja / Prayers, Puram = City. Hence it means the City where Brahma performed puja.

### **AATHI ATTHI VARATHAR**

Now coming to the main story & the Hero of this story; who is AATHI ATTHI VARATHAR & why is this Vaibhavam (festival) is celebrated for 48 days every 40 years.

Maha Vishnu is known as the deity that looks after on sustaining this entire creation of Brahma & has appeared when Dharmam (rightness) is in danger. Besides HIS Dasavatharam, HE has appeared in all 4 Yugams – Krethayugam as Varathar of Kanchi, Threthayugam as Renganathar of Rengam, Dwaparayugam as Jagannathar of Puri & Kaliyugam as Venkatachalapati of Thirumala. Referring to the meaning of Kanchipuram & relating it to this, it is believed that in Krethayugam Brahma performed a homam / yagam towards Lord MahaVishnu. To have Lord MahaVishnu appear, one has to perform thousand yagam & the only place that by doing just 1 yagam would have MahaVishnu appear was Kanchipuram.

This is because of this city's greatness – 1 equals to 1000. It's still believed up till now that any good deeds (Puja, Yagam, Thanam, Dharmam) done here is equivalent to thousand fold.

So the yagam done by Brahma was fruitful as MahaVishnu appeared in front of Brahma from the yaga kundam (sacrificial fire pit). Brahma was mesmerised by the charming looks of MahaVishnu & immediately started to sculpt the image of MahaVishnu on the Atthimaram (Fig tree) as there were a lot of this tree there.

The sculpted Murti was said to be 9ft in height & has a very captivating face with a smile that can steal ones heart (Mantha hasam). By seeing this image of MahaVishnu with Mantha hasam, sins done by one is believed to be gone.

Brahma was admiring the Murti & that admiration was stopped by a divine voice saying that since the Murti sculpted was an appearance from the yaga kundam; it is radiating heat and to reduce the heat on it, it has to be kept in cold water tank (pond).

Thus the pond named Ananthasiras Pushkarani was erected and the Murti was kept in that pond. As the Murti was kept there, the pond became holy & it's believed all the Saptha Nathi (7 sacred rivers – Ganga, Yamuna, Godhavari, Saraswathi, Narmadham Sindu, Kaveri) & all the sacred oceans are in the waters of the Ananthasiras Pushkarani.

\*\*Ananthasiras Pushkarani is located left of the Kanchi Varatharaja Perumal Temple if entered thru the main entrance.

In Kanchi Varatharajar Temple the Aathi Atthi Varathar is the original Mulavar (Main deity at the main sanctum) but since HE is placed in the Ananthasiras Pushkarani, a replica of the Mulavar was found at Pazhayachivaram as guided from the divine voice that told Brahma to place the sculpted Murti in the pond. The Mulavar that many see now is known as Devaraja Perumal.

There are 5 Murtis (Idols) of Perumal here in Kanchi Varatharaja Perumal Temple. They are:

1. Aathi Varathar – Sculpted from the tree and taken out from the pond every 40 years.
2. Mula Murthi – The main deity in the main sanctum which is Devaraja Perumal.
3. Swayambu Murthi – The deity that emerged from the Yaga Kundam.
4. Utchava Murthi – Panchaloga diety (made out of the 5 metals) that is taken around on special occasions on various Vahanam (vehicle) and Ratham (chariot).
5. Velli Murthi – The deity that is daily worshiped together with the Mula Murthi in the main sanctum. Daily Thirumanjanam (ritualistic bath) is done for this murthi.

### **AATHI ATTHI VARATHAR VAIBHAVAM**

As being said that every 40 years once the Aathi Varathar that is kept in an underground chamber in the Ananthasiras Pushkarani is taken out to have puja (prayers) offered to. As mortals we are, the earliest recorded date of the festival was dated on 12th July 1937 & then it was in 02nd July 1979.

In 1979, only hundreds of people witnessed and was part of this festival but no one would have thought that more than 1 crore devotees would witness and be part of this festival 40 years later.

It was held from 01st July 2019 up to 16th August 2019 for 47 days. As the Aathi Varathar is taken out the day before the festival, HE is given a simple Thirumanjanam & then decorated to be kept in the in the special mandapam (decorated dais) for the viewing of the devotees. For the first 37 days Varathar is in the Kidainda Kolam (Sleeping position) and in the Nindra Kolam (Standing position) for the last 10 days.

On the 48th day, before HE is immersed back into the Ananthasiras Pushkarani, the deity is anointed with Sandhanadhi thailam (a concoction mix containing saffron, vetiver, velamuchi ver, sambrani, cardamom, nutmeg, lavangam) to protect it from fungus & termite.

Then the Swasthi Vaachanam will be chanted followed by 40

Sripadam Kainkarya members who then carry the idol which is placed on a palanquin up to the pushkarani, stopping in front of the mandapam which is on the pushkarani.

From there the priests will lift the idol physically and take it to the underground chamber. Naga stones are then placed on the idols' shoulders, feet & hips to prevent it from floating. And as this takes place, the skies will darken & pour its heart out to fill the pushkarani where the waters were drained out when the festival started. Thus the Vaibhavam ended with lots of fanfare and to be celebrated again in the year 2059.

### **MY EXPERIENCE**

So many of you must be wondering how I know all this with full detail; well my Amma & I were part of the 1 crore devotees who celebrated this festival in Kanchipuram with many others Hindu devotees from parts of India & from Malaysia, Singapore, Sri Lanka, UK, Europe and USA.

We flew to Chennai on 12th August 2019 (Monday) & headed straight to Kanchipuram that night. We somehow found our way to the temple and joined the VIP line which had few hundreds waiting already.

We walked slowly with the crowd starting at 4am IST (Tuesday, 13th August 2019). All was well for the first 2 hours or so but then I guess Varathar decided to test my devotion, faith & trust as I started experiencing dizziness and was in the verge of fainting as the crowd was not moving at one point.


At that split point I questioned myself, "Pravin, is this really what you wanted?" and quickly I told myself, "What ever may it be, I will see you Varathaaaa!!!!!"

With that the crowd started moving & after nearly 5 hours in line, we finally saw HIM, and if having dizziness with the verge of fainting twice made me see HIM twice up close, well that was truly worth it as many only saw HIM one time just for seconds & some after seeing the long line of people and wait decided not to see HIM but I saw HIM for a total of nearly 1 minute combined; best reward for my determination I guess.


Then we exited and headed to Kanchipuram town centre, to Gandhi Rd to have our breakfast and also purchase new footwear as what we wore earlier was somewhere else.

We spent a good time visiting some saree shops to pass time as we had an audience with the Queen of Kanchi which was not until 3.30pm. It was a memorable evening with HER as we witnessed the evening Abhishegam & Special Prayers as it was the last Tuesday of the month of Aadi. Then we visited Kanchi Ekambaranathar Temple before heading back to Chennai for leisure & shopping as were to return back to Seremban on 20th August 2019.

In a summary I never thought all the excitement would get to me but it did & I am glad I went because I don't know how I would be in 2059 but if HE wishes Me to see HIM, I would truly be delighted to go for it.

## **The Good Old Days, Growing Up Experience by Mr Thiagarajan Mathiaparanam (KJB Klang)**

Life during the 50s and 60s is incomparable to that of what it is now. The standard of living has improved by leaps and bounds. Those born during the 70s and 80s onwards can be said to be the more fortunate ones.

During my childhood days, it was a constant struggle to put food on the table for most of the parents. Digging deep into the recesses of my memory, I would like to trace back some of the basic measures that were practiced to be prudent, to survive. I, being the 7th of 8 siblings, would not know how life was for my elders during the 40s.

During our schooling days, there was no free school textbooks given to the students. So, as soon as the booklist was out, we would use a ruler to strike out those books which we would receive from our elders. Then, we would quickly do some networking to get as many of the remaining textbooks from seniors at half-price.

I, never saw a plastic hand pail during my younger days. We improvised by cutting open an empty Planta margarine rectangular tin. Using a hammer, the sharp edges were smoothed. An old broomstick is then sawed to size and placed between the opposite sides of the tin and nailed, so as to be used as a handle.

As far as cooking was concerned, gas stoves were unheard of. Firewood was used as fuel for cooking. A bullock cart load of firewood would be split into finer strips with an axe. A muscular guy by the name of Avadiar, in the mould of Charles Branson would be called to do the job for a nominal fee.

Daily bathing with warm water was out of the question. Bathing in cold water was the norm. The initial few scoops of water poured were the most torturous. One had to grit one's teeth and bear with the ice cold water. Only when one was unwell, was one "privileged" to bathe in warm water.

Grooming our hair with Brylcreem or Tancho branded hair cream was beyond the budget. Every member of the family had to use the fragrant smelling green coloured hair oil by the name of Chandanadi Hair Oil. Come to think of it, we had already gone "green" during the 50s itself. This hair oil has passed the test of time, as it is still available at the Indian sundry shops.

Just to dwell a bit on it, this Ayurvedic oil is made using a range of medicinal herbs, with sesame oil as its base. It prevents greying and hair fall. The oil works as a coolant, and thus balances body heat.

Similarly, hair shampoo was a no-no those days - being too expensive for a family of 10. Weekly oil baths were mandatory. Shikakai fruits (Acacia Concinna) were boiled until it became soft, and applied on the head and massaged. It was supposed to give a cooling effect. The hair after that would be soft and puffed up like cotton.

Shikakai fruits were used traditionally for hair care since ancient times. Literally meaning "Fruit of the Hair", it's considered by some to be a better approach to hair care than the chemicals in many shampoos.

We were fortunate to have 2 meals per day. But, chicken was a luxury and was cooked only once a week, on Sundays, unlike nowadays, where it is consumed every other day. Fish was much cheaper then, and was eaten some of the days. We observed a vegetarian diet on Fridays.

The rearing of fowls provided us with a constant supply of eggs to supplement our diet. We had a brood of 20 fowls. At times, my mother would keep some of the eggs for hatching purposes. In a rectangular cream crackers tin, was spread a layer of paddy. The eggs were placed on this paddy spread for safe keeping.

Once about a dozen eggs had been collected, they were placed in an egg nest, made up of hay. The broody hen would sit on it for 3 weeks before hatching could take place. The highlight was to see the beaks of the chicks pointing out of the egg shells; and its process of breaking out of the egg shells into cute fluffy chicks.

Badminton was the craze of our family, and was played by every member of the family. The best shuttlecocks were the Dunlop, RSL and Bluebird brands. The Bluebird shuttlecocks came with 2 tiny ball bearings embedded within it for aerodynamic purposes. These shuttlecocks cost RM 2.40 each and were deemed too expensive. Aeroplane brand shuttlecocks were slightly less expensive, costing about RM 1.00, and was used sparingly and carefully.

To cut costs, my brother would recycle them. From some of the damaged shuttlecocks, he would pluck out some of the better feathers and carefully insert them into another shuttlecock and add some glue to it. It was as good as new! These reconstructed shuttlecocks would last for quite a while too.

Spring cleaning for the Hindu New Year or Deepavali was by an innovative way. My elder brothers would go into the “belukar” behind our government quarters house in Raub, to cut some bamboo leaves and a sturdy stem. I escaped doing this as I was very much younger. The bamboo leaves would be arranged at one end of the bamboo stem and tied tightly. This was then swayed left and right to wipe out the cobwebs and dust on the ceiling. I must have had rhinitis then, because on each occasion when the house was being spring cleaned, I would be sneezing the whole day through.

On a lighter note, deworming exercise was done under the watchful eyes of my mother, for the 8 of us, the cost effective way. On a fine Sunday, 8 small cute glasses would be lined up, each filled with a small “peg” of castor oil. Swallowing it was a horror show. Only the daring one would coolly take it to the verandah, under the pretext of consuming it, and in a split second, wrist flick its contents into the poor flower pots outside.

It was a marching procession to the toilet, which was a good distance away, for most of the day. Even the daring one, who didn’t consume the oil would join in the parade nonchalantly.

Being a pensioner now, and having the time to reflect on our lives more than 6 decades ago, we are able to withstand the present day perils that life has to offer, due to the hardships and sacrifices that we had undergone yesteryear.

The First Annual General Meeting of the Society was held on 20<sup>th</sup> September 1925 at 10.00 am at the Town Hall, Kuala Lumpur. The number of members on the Register on 30<sup>th</sup> June 1925 was 1044 with a total subscription of \$6034.00. Of the total 1044 members 918 of them were Government servants. This gives an indication that 88% of the working members of the community then were employed by the Government with 12% in the private sector. In all principal towns Sub-Committees were appointed and their duties were to investigate into and report on loan applications, to enlist members and generally promote the interest of the Society in the Districts.
